## **BREEDING CONTRACT - MINOR ORDEAL**

This Agreement, by and between Sugar Creek, LLC ("Sugar Creek") and the undersigned Owner or Lessee of the mare described below ("Mare Owner):

- 1. Breeding Fee. The breeding fee shall  $\Phi$

- 2. OtherServicesandExpenses. It is understood that in addition to the above-stated breeding fee Mare Owner(s) shall pay a lab processing fee of \$20 per insemination dose. This fee applies to all inseminations of mare by stallion. Mare Owner shall pay stall board expenses at the rate of
- \$20 peradayforadrymare\$22 perdayforawetmare(withfoal)or\$12 perdayformareinpasture, plusveterinarianservices and related expenses including transportation to aveterinary facility, farrierservices, special dietary services, and all otherservices and expenses reasonable or appropriate to ensure the well-being and breeding of the Mare and/or foal. Board and veterinary fees subject to change. Sugar Creek will issue monthly statements of all such charges pertaining to board and services provided directly by Sugar Creek and veterinarian service and other vendors will bill directly to the Mare Owner. Mare Owner agrees to pay these charges in full upon receipt. Such charges shall be paid in full whether or not the Mare is settled/pregnant. In the event such payments are not received when due, Mare Owner acknowledges and agrees Mare Owner shall pay to Sugar Creek a 1.5% monthly (18% perannum) carrying fee on the total sum of any amount not paid when due. Mare Owner shall pay all reasonable attorneys' fees, paralegal fees, accountant fees and any other cost and expenses incurred by Sugar Creek inpursuing collection of the sums owed under this Agreement.
- 3. Conditions for Acceptance of Mare. Aphotocopy of both sides of the Mare's registration papers must be furnished and returned with this Agreement. Mare Owner represents and warrants that the Mare is healthy, of sound breeding condition, halter broken, is free from infection or disease and that the Mare tested negative on a Coggins Test performed within six (6) months prior to the Mare's arrival at Sugar Creek the Mare must have a veterinarian's health certificate including worming and vaccination records and a current negative Coggins Test. If these documents are not presented in acceptable for mupon the Mare's arrival, Sugar Creek shall have a veterinarian make propertes and evaluation at Mare Owner's expense. Sugar Creek reserves the right to refuse acceptance of the Mare if in the opinion of Sugar Creek, the Mare is not in satisfactory condition. If the Mare is refused, the rewill be no refund of the breeding fee. Another mare owned by Mare Owner may be substituted. If nother mare is available this Agreements hall terminate and the parties shall be relieved of any further obligation sor liability hereunder, except Mare Owner's obligation to remove the Mare from Sugar Creek at Mare Owner's expense and Mare Owner's obligation to pay any outstanding charges and expenses.
- **4. Breeding and Risks**. Sugar Creekwill use reasonable diligence to settle the Mare and shall have sole discretion in determining the method of breeding the Mare. Should the Mare not settle, Mare Owner releases and holds harmless Sugar Creek from any resulting losses or damages. Mare Owner fully understands, authorizes and assumes the inherent risks and dangers in keeping, breeding and transporting horses and acknowledges that mortality and other insurance is solely the Mare Owner's responsibility.
- 5. Transportation and Release. Mare Owner shall be solely responsible for arranging and paying the costs for transporting the Mare. The Mare will not be released to Mare Owner or any agent until all fees and expenses are paid to date. Sugar Creek shall have a lien against the Mare and/or foal until such time as all charges and expenses are paid in full. This lien shall survive any transfer of possession. Mare Owner shall provide Sugar Creek with reasonable notice of intent to pick up the Mare. Mare Owner shall provide Sugar Creek with written authorization to release the Mareto any third partytransporterand Sugar Creekshall have no obligation to release the Mare without such written authorization. Upon commencement of the loading of the Mare by a third party transporter, Mare Owner assumes full responsibility and liability for the health, welfare, care, soundness, breeding condition, and transportation of the Mareandany such foals.
- **6. Shipping Terms and Conditions.** Breeding provided by fresh cooled semen will be shipped according to the terms and conditions for shipped cooled semen set forth in Addendum A and fully incorporated herein. Breeding provided by frozen semen will be shipped according to the terms and conditions for frozen semen set forth in Addendum B and fully incorporated herein. (Click on Addendum A or Addendum B for the document you desire.)

- 7. SemenHandling-ForTransportedSemen. Mare Owner agrees to assume responsibility for all facets of breeding the Mare and agrees to comply with all breed registry requirements concerning the use and handling of cooled or frozen semen. Sugar Creekagrees to ship semen to the location designated by Mare Owner, but Mare Owner agrees and certifies that only a qualified and experienced person in the use and handling of transported semen and who practices equine reproduction as a regular part of his/her practice will perform the insemination. Mare Owner agrees to use all semen provided by this Agreement solely to breed the Mare named in this Agreement. Any attempt to use any portion of any semen shipped to Mare Owner to breed any mare other than the Mare shall automatically terminate all obligations of Sugar Creek under this Agreement and result inforfeiture of all breeding fees, balance of shipping fees, collection deposits and the right to a breeder's certificate. If multiple transports of semen are requested, Sugar Creek reserves the right to request a negative uterine culture, cytology or biopsy prior to providing further semen for insemination. Sugar Creek in its sole discretion may refuse to provide semen if Sugar Creek believes the insemination is not proper or the Mare(s) is not healthy. Mare owner agrees to pay the shipped semen charge of \$275 for each semen shipment. Payment must be made before semen is shipped. Shipments to Canada require more documentation and an increased cost. Canadian breeders please contact our office for details.
- 8. Disclaimer. Sugar Creek will use reasonable efforts to provide semen for transport on a first call, first serve basis. Mare Owner acknowledges that this Agreement does not guarantee semen will be available. Sugar Creek makes no representations or warranties, expressed or implied, regarding the semen delivered under this agreement, including without limitation, representations or warranties that the semen will safely reach the insemination point without losing its integrity, quality or other characteristics. Sugar Creek makes no representations or warranties, express or implied, regarding the delivery of the semen under this Agreement, and shall not be responsible for delayed, lost or mishandled deliveries. Semen will be collected only on established breeding days and no representations or warranties are made or implied that the semen will be available at the time requested by Mare Owner. Mare Owner hereby disclaims and releases Sugar Creek from any liability, damages, claims, causes of actions, or losses with respect to the breeding of the Mare, this Agreement and the shipment and collection of the semen, including but not limited to consequential damages, lost breeding opportunities or lost profits. Mare Owner agrees and acknowledges that Sugar Creek hasnot made and does not make any representation or warranty asto the quality or conformation of the foal or that the foal will be free of any infirmity, conformation defect, disease or inherited trait. SUGAR CREEK DISCLAIMS ANY WARRANTIES, EXPRESSED OR IMPLIED, INCLUDING WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE IN CONNECTION WITH THIS AGREEMENT AND THIS BREEDING. The parties here to specifically agree if a dispute between Mare Owner and Sugar Creek arises, Mare Owner's damages, expenses, costs and fees including attorneys' fees for such dispute, whatever the nature of the dispute, shall be limited to an amount equal to the breeding fee specified herein.
- 9. Live Foal Guarantee. This agreement begins the day it is signed by the mare owner and all stallion service fees are paid. Any time limitations begin on the first day mare is inseminated, which must occur within 12 months from signing this agreement. Sugar Creek provides a limited guarantee that as ingle live foal will result from the breeding privileges granted herein. The term "live foal" means that a foal stands alone, nurses and lives for twenty-four (24) hours. If a live foal does not result from the breeding, Mare Owner shall be entitled to return the Mare or a substitute mare approved by Sugar Creek for breeding to the Stallion for the following breeding season only. If the Mare Owner chooses to exercise the option to rebreed in a subsequent breeding season, Mare Owner is responsible for payment of all boarding charges and expenses for that subsequent season, but without payment of any further breeding fee. Mare Owner also remains subject to all terms and conditions of this Agreement. This obligation by Sugar Creek to rebreed will apply only if the Mare Owner notifies Sugar Creek within forty-eight (48) hours of foaling that the Mare did not produce a live foal and within fourteen (14) days after the Mare Owner's notice to Sugar Creek Mare Owner certifies to Sugar Creek that the birth was properly managed and also produces a statement from a licensed veterinarian stating details explaining the failure of the Mare to produce a live foal. It is agreed that this provision will be of no further effect if the Mare is taken to any other stallion before returning to the Stallion. If Mare Owner fails to rebreed the following year, then any and all fees paid shall be forfeited, the right to rebreed is canceled and Sugar Creek is released from all obligations of this Agreement.
- 10. Certificate and Multiple Foals. Upon notification of birth of a live foal and full payment of all fees and expenses and the performance of all other obligations of Mare Owner under this Agreement, Sugar Creek shall issue one breeder's certificate to the Mare Owner. Should more than one embryo or foal result from a breeding, Mare Owner shall pay an additional breeding fee, including the booking fee, for each embryo or resulting foal. Such payments hall be due within 60 days of breeding if embryos are flushed from the Mare or within two weeks of foaling in case of twins in order to receive a breeding certificate for the additional foal.
- 11. Substitution. This contract cannot be traded, sold or transferred, in any fashion, to another party. If the Stallion dies, is unavailable, or becomes unfit for service, and the Mare is not in foal, this Agreement shall become null and void. Sugar Creek, at its sole discretion may substitute another stallion in this event only with written consent of substitute stallion's owner. No refund will be made on the breeding fee.
- 12. No representations or Warranty. Mare Owner agrees and acknowledges that Sugar Creek has not made and does not make any representation or warranty as to the quality or conformation of the foal or that the foal will be free of any infirmity, conformation defect, disease or inherited trait.

SUGAR CREEK DISCLAIMS ANYWARRANTIES, EXPRESSED OR IMPLIED, INCLUDING WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE IN CONNECTION WITH THIS AGREEMENT AND THIS BREEDING.

- 13. Waiver/Indemnification. Sugar Creek shall not be liable for any damages to the Mare arising out of or from the keeping or breeding of the Mare or that may occur from any cause whatsoever in connection therewith including but not limited to loss by fire, theft, running away, death, or injury during or after the term of this Agreement, whether the Mare is on Sugar Creek property or not. Mare Owner shall be solely responsible for all acts and behavior of the Mare at anytime during the term of this Agreement and in no case shall Sugar Creek, its owners, management, agents, and/or employees be held liable. Owner shall indemnify Sugar Creek, its owners, agents, management, and employees for all damages sustained or suffered by reason of the breeding or keeping of the Mare and for any claims arising out of the breeding act or keeping of the Mare. WARNING: Under Tennessee law, an equine professional is not liable for an injury to, or the death of, a participant in equine activities resulting from the inherent risks of the equine activities.
- 14. Miscellaneous. It is further agreed: (a) this Agreement constitutes the entire agreement between both parties hereto and there are no binding agreements, understandings, restrictions, warranties or representations between the parties other than those set forth herein; (b) this Agreement cannot be amended except in a writing executed by all parties hereto; (c) this Agreement may not be assigned or transferred in any manner, absent the express written permission of Sugar Creek; (d) this Agreement shall be governed by the laws of the State of Tennessee and shall be binding upon the heirs, personal representatives, successors, agents and permitted assigns of the parties; (e) all actions concerning this Agreement shall be instituted in the Bedford County Circuitor Superior Courts, Shelbyville, Tennessee, or in the United States District Courtfor the Middle District of Tennessee, Nashville Division and Mare Owner irrevocably and unconditionally submits to the personal jurisdiction of said courts; (f) Mare Owner acknowledges that failure of Sugar Creek to require performance of any provision of this Agreement shall not affect Sugar Creek' right to later require performance, nor shall a waiver of any breach or default of this Agreement constitute a waiver of any subsequent breach or default or a waiver of the provision itself; (g) the person executing this Agreement on behalf of the Mare Owner is fully authorized to execute this Agreement on behalf of Mare Owner; (h) should it be necessary for Sugar Creek to employ an attorney to enforce any of the terms of this Agreement, including collection of money owed, Mare Owner shall pay all attorney fees, paralegal fees, accountant fees and any other costs or expenses incurred by Sugar Creek; and (i) Mare Owner acknowledges that Sugar Creek acts solely as agent for the owner of the Stallion, and Sugar Creek will be bound by the terms of this Agreement only for so long as Sugar Creek is designated as the agent for the Stallion.
